

## **“GO BOWLING WITH ARIC ALMIROLA AND KYLE TROUP EXPERIENCE” SWEEPSTAKES**

### OFFICIAL RULES

#### NO PURCHASE NECESSARY

1. **PROMOTION DESCRIPTION:** The **“Go Bowling With Aric Almirola and Kyle Troup Experience” Sweepstakes (“Sweepstakes”)** begins at 12:00:00 AM Central Time (“CT”) on 8/1-22 and ends at 11:59:59 PM (CT) on 9/05/22 (“**Promotion Period**”) for all methods of entry. The Sweepstakes will award one (1) Grand Prize in the Sweepstakes. Sweepstakes entry will be available at [www.GoBowling.com/AricandKyle](http://www.GoBowling.com/AricandKyle) (the “**Website**”). Entries received after the expiration of the Promotion Period will not be included as entries into the Sweepstakes. For purposes of these Official Rules, a “Day” is defined as each twenty-four (24) hour period during the Promotion Period beginning at 12:00:00 AM (CT) and ending at 11:59:59 PM (CT).
2. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 21 years of age or older at the time of entry. Employees of Strike Ten Entertainment (“**Sponsor**”), its parent company, affiliates, subsidiaries, suppliers, advertising and promotion agencies and anyone else connected with the production and distribution of this Sweepstakes (collectively, the “Promotion Entities”) and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of wherethey reside) and/or those living in the same household of each are not eligible to participate. Void where prohibited.

**ALL ELIGIBLE SWEEPSTAKES ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD WILL BE ENTERED INTO THE GRAND PRIZE SWEEPSTAKES DRAWING.**

If for any reason during the Promotion Period a submission is not compliant with these Official Rules as solely determined by Sponsor, the submission will be disqualified from the Sweepstakes. All entry materials become the property of Sponsor and will not be returned.

NOTE: Entries must be made solely by the entrant. Entries made by any other individual or any entity, and/or originating at any other website, email address, or Social Platform account, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. Sponsor is not responsible for any change of email address, mailing address and/or phone number of entrants.

The Websites' database clock will be the official timekeeper for online entries in this Sweepstakes. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. "Authorized Account Holder" means the natural person who is assigned to an account by Sponsor, or its Go Bowling Squad administrator, Social Platform administrator, Internet access provider, online service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Entrants may not participate with multiple Go Bowling Squad accounts, Social Platform accounts and/or email addresses nor may entrants use any device or artifice to enter as multiple entrants in the Sweepstakes. Any entrant who attempts to enter with multiple Go Bowling Squad accounts, multiple email addresses, under multiple identities or uses any other device or artifice to enter multiple times beyond the entry limitation stated above will be disqualified from participation and all entries submitted by that entrant will be void. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of mailing address, email address, and/or telephone number of entrants. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.

4. **GRAND PRIZE WINNER SELECTION AND NOTIFICATION:** One (1) Grand Prize winner will be selected in a random drawing on or about 9/9/22 from among all eligible entries received by Sponsor or its designee. Any potential Grand Prize winner will initially be notified by email from the Sponsor. Decisions of the Sponsor or its designee are final and binding. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond upon immediate notification within forty-eight (48) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be randomly selected in Sponsor's sole discretion. Sponsor, in its sole discretion, will attempt to contact up to two (2) alternate potential winners of the Grand Prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. 5. PRIZES/APPROXIMATE RETAIL VALUES (ARV)/ODDS: GRAND PRIZE SWEEPSTAKES - One (1) Grand Prize – Winner will receive a 3-day/2-night trip for winner and one (1) guest to Charlotte, NC plus \$200 cash. (“Grand Prize”) Average Retail Value of Grand Prize is \$1,750. Additionally, winner or his/her guest will have the opportunity to bowl a 10-frame game with Aric Almirola and Kyle Troup at a Go Bowling Member Bowling Center in the Charlotte, NC area that will be selected by Sponsor at its sole discretion. Grand Prize will include \$200 in cash for miscellaneous expenses, transportation etc. **Note: Participation as a bowler in this prize is physical in nature; individual selected to participate must be able to engage in a moderate to high level of physical activity associated with bowling a full 10 frame game. Guest of Grand Prize winner must be eighteen (18) years of age or older.** Grand Prize includes round-trip coach air transportation for winner and one (1) guest between a major commercial airport closest to the winner's primary U.S. residence (as selected by Sponsor in its sole discretion) and Charlotte, NC; standard double-occupancy hotel accommodations consisting of one (1) room for two (2) nights; the opportunity for winner or his/her guest to bowl with Aric Almirola and Kyle Troup during a Sponsor-selected time period between September 1, 2022 – December 31, 2022. The Go Bowling with Aric Almirola and Kyle Troup Experience portion of the Grand Prize will be two (2) hours from time of arrival at the selected Bowling Center till the end of the 10 frame game. **Trip must be taken during the Sponsor-selected time period or prize will be forfeited in its entirety.** No transfer or substitution of trip elements will be permitted. Winner and his/her travel companions must depart/return from the same major airport and travel on same itinerary. Trip is not redeemable for cash. In the event any scheduled event associated with the prize and/or any other component of the prize is cancelled, delayed, or postponed for any reason outside the control of the Sponsor, Sponsor will have no further obligation, other than to award the remainder of the prize. Sponsor reserves the right in its sole discretion to award the Grand Prize winner \$1,500 in cash in lieu of awarding the Grand Prize if either or both Aric Almirola or Kyle Troup has an unavoidable scheduling conflict and cannot participate in Grand Prize as defined in section 5. of these official rules.
